OFC. RAMIREZ LOST THE VEHICLE. A BOLO WAS ISSUED UNDER EVENT #2021-0012176. AT APPROXIMATELY 0400HRS, SGT. KHAWLY (CID #0836) OBSERVED A BLACK SEDAN EXITING THE WATERSTONE ENTRY/EXIT TO NE 43RD AVE AROUND THE 1000 BLOCK. SGT. KHAWLY WAITED FOR THE VEHICLE TO EXIT HOWEVER THE DRIVER TURNED OFF THE LIGHTS AND REVERSED BACK INTO THE COMMUNITY. SGT. KHAWLY APPROACHED THE VEHICLE, AND OBSERVED THE VEHICLE BEARING FLA TAG #CCIN11 WHICH MATCHED THE BOLO AND ACTIVATED THE EMERGENCY EQUIPMENT (LIGHTS AND SIRENS) ON HIS MARKED PATROL UNIT TO CONDUCT A TRAFFIC STOP. WHEN SGT KHAWLY APPROACHED THE VEHICLE, THE DEFENDANT/SUBJECT DROVE OFF SOUTHBOUND ON NE 43RD AVE AT A HIGH RATE OF SPEED TO EVADE HIM. SGT KHAWLY PURSUED THE VEHICLE IN EMERGENCY MODE AND THE VEHICLE WAS GAINING DISTANCE AWAY FROM SGT. KHAWLY. THE DEFENDANT/SUBJECT TURNED THE LIGHTS OFF ON THE VEHICLE WHILE TRAVELING WESTBOUND ON E. PALM DR. ATTEMPTING TO EVADE SGT. KHAWLY. THE DEFENDANT/SUBJECT FAILED TO MANEUVER THE CURVE AT 111 MPH AT 4 SECONDS OUT BEFORE THE CRASH PER THE BOSE CDR CRASH DATA RETRIEVAL INFORMATION.
